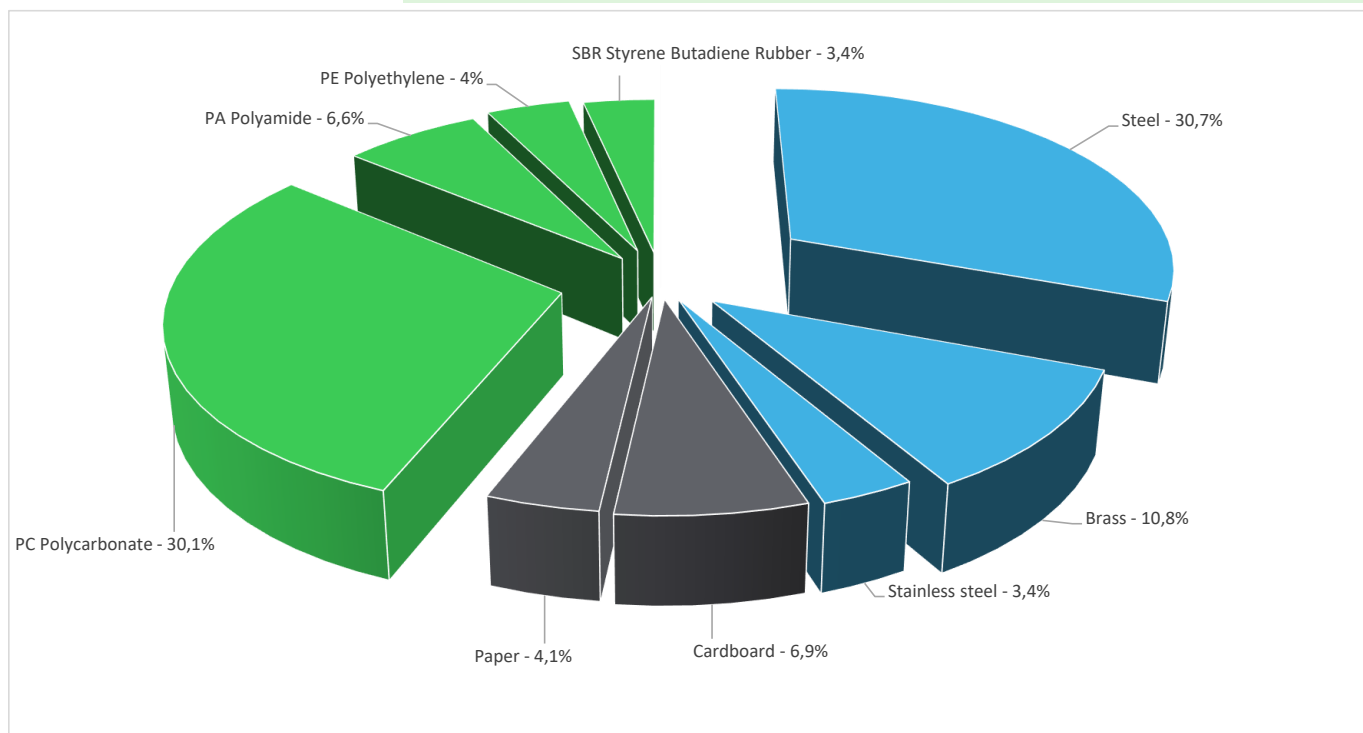
General information

Description of the product	The product is a weatherproof single socket outlet that serves users to connect and disconnect the plug of an electrical load and to connect to the electrical network.
