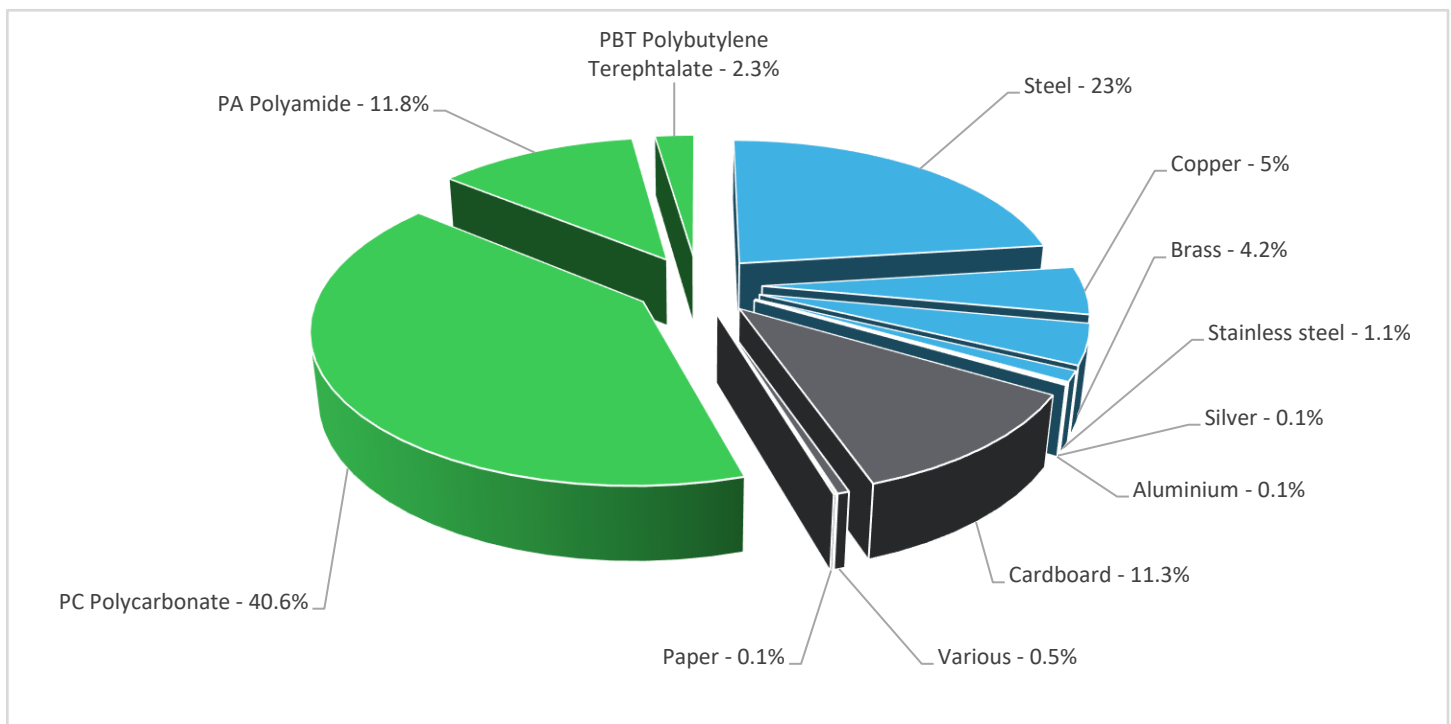


General information

Description of the product	The main purpose of the product is to isolate a circuit, to protect and/or to control a motor.
Functional unit	Switch on and off during 20 years electrical power supply of a downstream installation with an electrical and/or mechanical control. The functional unit is characterized by a 1NO+1NC, a control circuit voltage 230V AC, a power circuit 690V and a maximum allowed intensity by the power circuit 9A.

Substance assessment

Products of this range are designed in conformity with the requirements of the RoHS directive (European Directive 2011/65/EU of 2 January 2013, amended in March 2015, 2015/863/EU and in November 2017, 2017/2102/EU) and do not contain, or only contain in the authorised proportions, lead, mercury, cadmium, hexavalent chromium or flame retardants (polybrominated biphenyls - PBB, polybrominated diphenyl ethers – PBDE), Bis (2-ethylhexyl)phthalate - DEHP, Benzyl butyl phthalate– BBP, Dibutyl phthalate - DBP, Diisobutyl phthalate - DIBP) as mentioned in the Directive.

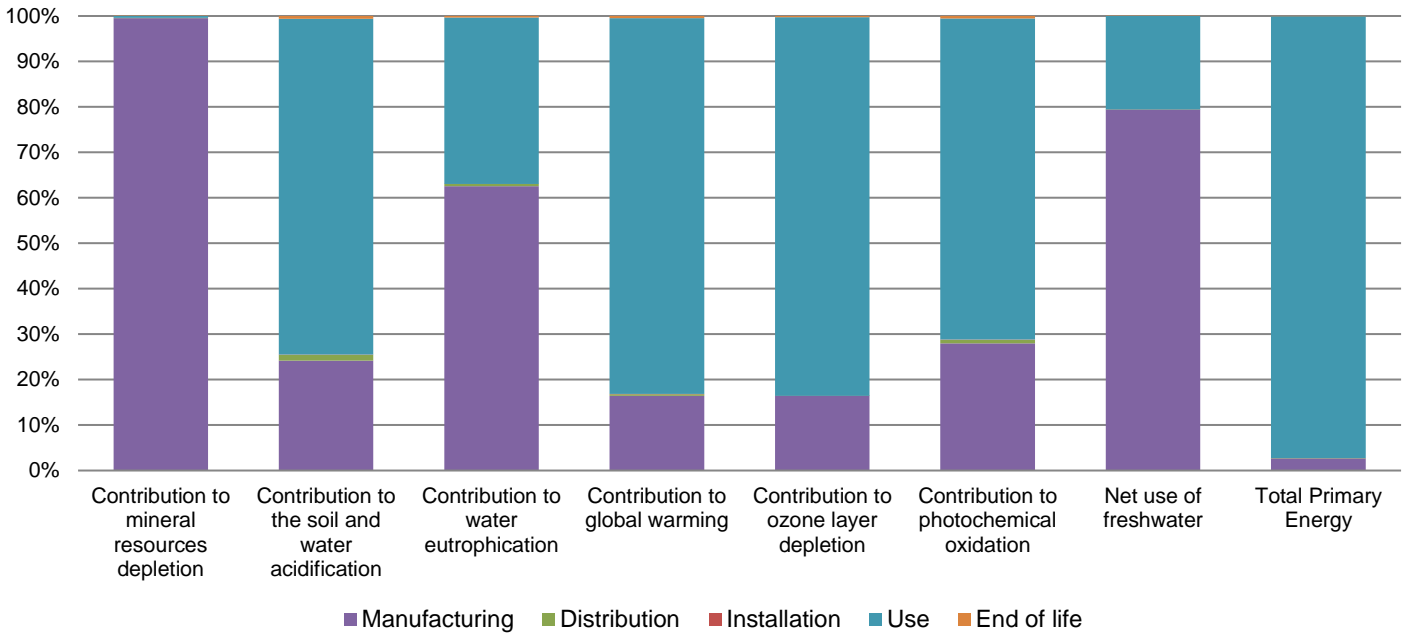
